# SCHOOL PARENT AND FAMILY ENGAGEMENT POLICY Joint Development and Distribution

Perry Lower Intermediate School developed its School Parent and Family Engagement Policy with parents of participating students. These individual meetings provide one-on-one conferencing with parents of eligible Title I students. Perry Lower Intermediate School also offers a variety of parent meetings/conferences at various times throughout the day.

Phone conferences, written communication, and face-to-face meetings are available to all parents. Title I funds are used to pay for reasonable and necessary expenses associated with parent involvement activities.

## Planning, Review, and Improvement of Program/Policy

Perry Lower Intermediate School involves parents in the planning, review, and improvement of the Title I Program, including the planning, review, and improvement of the School Parent Engagement Policy. Each year, a poll of randomly selected parents/guardians of Title I students will be taken in order to assess the effectiveness of the school's Title I program, School Parent Engagement Policy, District Parent Engagement Policy, and related activities. This input will solicit suggestions for improvement or revision.

## Information about the Title I Program

Perry Lower Intermediate School provides parents of participating students with timely information about the Title I program.
